TOWNSHIP MANAGER'S REPORT

### Delinquent Utility Bills

Westtown Township, in its endeavor to keep the rates it charges for trash collection and sewer rates at a minimum, will be stepping up the process of collecting overdue accounts. Past Township practice has been to send reminder letters to property owners whose bills have not been paid. In the future, if these letters do not result in the prompt payment of the overdue accounts, the Township will take legal action to enforce the collection. Such action involves considerable extra costs added to overdue account.

The intent of this action is not to penalize the delinquent property owners, but to avoid penalizing those who do pay their bills regularly and on time. The Township must meet its expenses and does not wish to raise its rates to make up for those who do not.

If you get a collection letter, please do not ignore it. Contact the Township Office. The staff will work with you to devise a payment program so that we can avoid taking legal action.

### Presby Homes – Makemie Ridge

Recently the Township was informed that Presby Homes was withdrawing the application for the Makemie Ridge project. Makemie Ridge was one component of a proposal which provided for a varied but unified development of the Crebilly Farm Property. At this time no other plans have been submitted for the development of the Crebilly Farm property.

SUPERVISORS REPORT

### A Winter to Remember

No one in Westtown will soon forget the Winter of 2009-2010 – especially the Township road crew that is responsible for clearing Westtown's 54 miles of roads and 91 cul-de-sacs. Despite four record snow storms from December through February, our road crew met the challenge.

The most demanding element of snow removal this year was the depth of each snowfall. The majority of our trucks are not large enough to plow the roads open to full width when totals exceed 18 inches of wet and heavy snow. Our workers, some of whom worked in excess of 30 hours straight, managed the challenge by non-stop, repetitive plowing throughout the storms.

Westtown recorded a total of 70 inches of snowfall for the Winter of 2009-2010: 20 inches in December, 3 inches in January and 47 inches in February. The Township declared local emergencies for all but the last storm in February, so road crew could exceed the normal hours behind the wheel.

The first large snow occurred shortly before Christmas. The crew worked

around the clock to keep the blizzard conditions from drifting and reaching levels that would make roads totally impassable.

The men never went home throughout the storm. They took breaks over

two days of the storm by sleeping on the floor at the Administration Building and the Police Station, so they could quickly get back on the road after a couple of hours sleep.

Just as the snow mounted up throughout the Township, so did the costs. Based on past winters, the Township budgeted \$130,000 annually for salt, extra equipment and outside drivers. The final seasonal costs amounted to \$164,000,

which is straining the Township's already tight finances. The State has created an emergency fund to provide additional funds to some local governments, and Westtown has applied. So far, no community in Chester County has been approved.

Adding to the challenges of snow clearing were downed trees and branches that had to be removed from the road. According to Mark Gross, Roadmaster, the greatest challenge was dealing with the high winds associated with the storms. Blowing and drifting snow decreased visibility while drifts were up to 5 feet deep in multiple locations.

Cars parked in the street caused special problems because the trucks could not properly clear the roads. The problem was especially troublesome in dense neighborhoods such as Coventry Village and Wild Goose Farm where roads are already extremely narrow.

Hats off to our road crew—Mark Gross, Westtown Township Roadmaster, Bob Doan, Dave Brown, Chris Culberson, Jon Pennington and 12 outside drivers—for a job well done, and one that we all hope is not necessary to repeat in years to come.

## The Westtown East Goshen Regional Police Department has forwarded the following Consumer Advisory

HARRISBURG - Attorney General Tom Corbett warned Pennsylvania consumers to be wary of a new type of aggressive financial scam involving scam artists who pretend to be family members supposedly involved in a traffic accident in Canada.

Corbett said the Attorney General's Bureau of Consumer Protection has received several complaints from senior citizens in southwestern Pennsylvania who have been targeted by the scam, including an 86-year old man who lost more than \$13,000 and a 71-year old woman who lost \$4,500.

"Criminals are trying to use fear, sympathy or emotion to convince consumers to quickly send money to a relative who has run into trouble while traveling," Corbett said. "This disturbing new telephone scam is focused on Pennsylvania seniors who believe they are doing the 'right thing' by helping a family member return home safely."

Corbett said that potential victims are receiving calls from a person claiming to be their grandson, who has been involved in a traffic accident in Canada. The "grandson" explains that he does not have insurance on his car and needs several thousand dollars - either to pay for repairs to

his own car or to pay for the damage that was done to another vehicle.

"In recent incidents, victims were instructed to visit their local Wal-Mart store and send a MoneyGram wire-transfer of \$4,500 to \$5,000 to a store in Ontario, Canada," Corbett said. "In both of these cases, the victims then received a 'thank you' call from their 'grandson,' followed by a request to send more money to pay for additional repairs, fines or travel expenses."

Corbett said these scam calls appear to be a variation of another Canadian telephone scam that the Bureau of Consumer Protection warned consumers about last month.

Corbett explained that during August residents in northeastern Pennsylvania were targeted by calls from scam artists posing as police officers from Canada. In those incidents, the caller claimed that the victim's grandson had been arrested for fishing without a license and requested that the victim wire-transfer \$2,800 to an address in Ontario, Canada, in order to secure the grandson's release.

Additionally, Corbett noted that other similar scams have been reported across Pennsylvania involving telephone messages left by individuals

posing as police or hospital officials, directing victims to call a special number to receive information about a relative who has been hurt in an accident. The phone numbers that consumers are asked to call are often international numbers, though they may appear to be ordinary U.S. phone numbers, resulting in expensive long-distance bills for unsuspecting victims.

"It is important for consumers to report suspicious calls as soon as possible, so that we can warn other Pennsylvania residents about possible scams and also so that local, federal and international law enforcement can investigate these crimes," Corbett said.

Consumers with questions or problems should contact the Attorney General's Consumer Protection Hotline at 1-800-441-2555 or file an online consumer complaint.

Additionally, Corbett encouraged consumers who have lost money as the result of these scams to contact their local police department and the nearest regional office of the Federal Bureau of Investigation in order to file a criminal report.

## STATE OF THE COURT 2010

District Court 15-2-03 Westtown, West Goshen & Thornbury Townships

Dear Friends, Neighbours and Fellow Citizens:

May I take this opportunity to extend a warm personal greeting to you. I want you to know that I am personally thankful for your continued faith and trust in me. I am committed to strengthening our community in the coming year, and I value having colleagues and staff who are dedicated to serving the public. It is the sworn obligation of a Judge to ensure that every case tried in his or her court is adjudicated expeditiously, courteously, and according to law, with the fullest protection for the rights of all who are involved. I try daily to follow this belief.

I am honored to present my annual "State of the Court" address to the citizens of Westtown Township. 2009 was a busy year for our court. I am proud to report that the state of Magisterial District Court 15-2-03 remains solid, sound and stable.

Pennsylvania's Magisterial District Courts are courts with limited jurisdiction. More than 90% of all litigation in Pennsylvania occurs in the courtrooms of Magisterial District Judges. Chester County has 19 Magisterial District Courts. All summary misdemeanor and felony criminal cases originate at the Magisterial District Court level. Magisterial District Courts are also the venue for lawsuits in civil cases for amounts up to \$8,000.00 as well as the filing and disposition of minor criminal cases (summary cases) such as traffic violations, disorderly conduct, public drunkenness, truancy, game law violations, and parking tickets. There is again legislation proposed to increase the Court's jurisdictional limits in civil matters from \$8,000.00 to \$15,000.00. As I have told you in the past this will have a significant impact on the volume of cases heard by Magisterial District Courts.

As a Magisterial District Judge I conduct preliminary hearings for all serious criminal offenders to determine which cases should be held for trial at the Court of Common Pleas. I also set and accept bail and arraign defendants after arrest. I issue search warrants based upon testimony from our local police force and the state's Attorney General's office.

Public trust and confidence begins with a fair and impartial judiciary. Every day I and the other District Judges work to provide resolution of disputes, to protect constitutional rights, and to uphold the rule of law. District court 15-2-03 is one of the busiest district courts in the county. Our caseload for the year 2009 was 6,309 cases filed. The cases filed in 2009 broke down as follows: 334 criminal cases, 507 civil cases, 4,510 traffic cases, and 958 summary cases. For the year 2009 the gross amount of

revenue District Court 15-2-03 took in was \$994,502.10. Of that Westtown Township received \$42,692.79, an increase of \$10,000.00 from 2008.

During the past year I could not help but notice the rising number of middle class young adults involved in violence, underage drinking, burglaries, robberies as well as an increasing numbers of drug crimes. DUI related matters, and incidents of domestic violence were also on the increase. Those matters plus more appearances by self-represented litigants, shifts in our economy, and a more diverse population are some of the changes that have affected our township and placed different and greater demands on our court.

District Court 15-2-03 is located at the Government Services Center (GSC) 601 Westtown Road, Suite 110 West Chester, PA 19380. Our telephone number is 610-436-5757, our fax number is 610-431-5755 and the now active court website is [www.chesco.org/judgekraut](http://www.chesco.org/judgekraut). The court's hours are Monday thru Friday 8:30 AM until 4:30 PM. The court's jurisdiction includes Westtown Township, West Goshen Township and Thornbury Township Chester County.

My door is always open. If you have any suggestions on making the court run more efficiently or how our court can better serve the public please let me know. Keep in mind that I cannot and will not discuss a case that I am to hear. The court staff nor I can give legal advice to the public, so please do not get angry at the staff when they tell you they cannot answer your questions. They are under strict orders not to give legal advice. The public and I are very fortunate to have the staff that is employed at our court. They are a dedicated, hard working and conscientious group of people. Without them the court would not run as effectively and efficiently as it does.

I am available to speak to civic groups, scouts, and schools. Tours of the court are available for schools and scouts.

In closing as I start each day I try to remember the following" the most extraordinary aspect of the judiciary in a free society is that even while exercising the authority entrusted to them, judges remain the servants, not the masters, of those on whom they sit in judgment." Have a happy and healthy year.

## Middle School Students Participate in Robotics Tournament

On January 9th, a team of seventh graders from Saint Maximilian Kolbe School participated in the First Lego League Robotics tournament at Oxford High School. The theme of this year's competition was Smart Move, and it included development and programming of a robot to perform specific "transportation-related" tasks. Also, for the research part of the competition the team chose to investigate and recommend improvements to rush hour traffic. They sent a web survey to family and friends questioning their experiences regarding their daily commute to work.

Results of the survey indicated that over 98% commute to their jobs in a car, and of that 98% only 3% of them travel in a carpool. Commuting during rush hour takes 25% longer, and 30% are not satisfied with their commuting time.

The survey participants recommended the following ideas to reduce rush hour traffic: 1.) Car and Van Pooling; 2.) Telecommuting; 3.) Flexible Work Hours; 4.) Better Access to Public Transportation; and 5.) Reducing Accidents. The use of public transportation not only reduces traffic, but it lowers pollution, is safer, and is kinder to the environment. A couple of effective ways to avoid accidents in this area are deer awareness (especially at dawn and dusk) and avoiding cell phone use while driving.


It was noted from the survey responses that it is difficult in Chester County to get to public transportation, such as the train. The team thought it would be a great idea to start a van pool to transport commuters to public transportation centers.

Based on their presentation, the team won an award in Innovative



Solutions advancing them to the regional finals. The regional finals were held on January 30th at the University of Delaware. At the regional finals the team scored 340 out of 400 possible points for the performance of their robot.

## RECYCLING AND TRASH INFORMATION

### IMPORTANT NOTICE

As of January 2010 Pennsylvania Department of Environmental Protection regulations specify that all yard waste (branches, leaves, clippings) must be composted. Yard waste can only go to the composting facility at the landfill. Residents can no longer include yard waste with the regular trash collection. Westtown Township will be providing additional yard waste collections throughout the year. Once the dates are finalized they will be posted on the Township website [www.westtownpa.org](http://www.westtownpa.org) and in the Township Newsletter. As with leaf collection all yard waste must be placed in biodegradable paper bags or a container that can be dumped. IAs with leaf collection, all yard waste must be placed in biodegradable paper bags or an open container that can be dumped. These are State regulations. The Township risks being fined if it permits violations. Any comments or questions on this requirement should be directed to your State Representatives. They are:

### How to Prepare Items for Recycling

**Glass—Green, Brown & Clear:** Bottles or Jars only. Rinse Clean. Remove lids and rings. Labels may be left on. *NO plate glass, ceramics, drinking glasses, etc.*

**Plastic:** Must be marked with #1 through #7 inside triangle on bottom. Rinse clean. Remove lids and discard. Labels may be left on. *NO unmarked containers or containers marked with other than #1 through #7 inside the triangle on bottom.* No antifreeze or motor oil containers.

**Aluminum Beverage Cans:** Rinse clean. Cans may be flattened. No bottle or jar lids, no pie plates or aluminum foil. *No other aluminum items.*

**Bi-Metal Cans:** Rinse clean. Cans may be flattened. Examples include pet food cans, soup cans, vegetable cans. *NO cans with plastic parts. NO paint or aerosol cans.*

**Newspaper, Magazines, Phone Books, Junk Mail, small cardboard boxes (cereal, crackers, etc) & Office Paper:** Combine in paper bag or bundle and tie.

**Cardboard Boxes:** Must be cut in three foot squares, tied and placed next to the recycling bin. This is necessary because of the compacting system of the recycling truck. Unfortunately if the cardboard is not prepared this way it will be taken with the regular trash. Cereal boxes and similar cardboard items may be combined with newspaper.
