



## *In Memory of Dr. Kenton Stokes*



On April 23rd Westtown Township lost one of its most dedicated and distinguished citizens. Unexpectedly, Dr. Kenton Shawl Stokes passed away, leaving a definite void in the Township family.

Kenton Stokes generously volunteered his time and expertise to the Township for more than half of his 64 years. In this time he served on the Board of Supervisors for thirteen years, as a member of the Environmental Conservation Commission, the Planning Commission, and the Parks Advisory

Group. He was Chairman of the Zoning Hearing Board at the time of his death. These were years in which Westtown Township was transformed by the onslaught of development. Skilled hands were necessary to assure that the best interest of the community was always primary. And no one was more skilled nor had the interest of the Township more at heart than Dr. Stokes. We all owe him an enormous measure of gratitude for his efforts.

And yet, that is not what we appreciate most about Kenton Stokes. We will best remember him not primarily for his good deeds, but for the grace and humor he brought to even the most difficult situations. In conducting the affairs of the Township, Dr. Stokes left those around him assured of the rightness and sincerity of his efforts and confident in their outcome. He made all of those around him appreciative of the association. This is what we will remember and what we will miss the most.

## RECYCLE, YOU MUST!

As mandated by the State, Westtown has had a curbside recycling program for its residents for the past seventeen years. Recycling, besides helping the environment by limiting the amount of refuse that goes to the landfill, also has a financial benefit for you as a resident. Almost 30% of the Township's budget for solid waste collection is the Landfill tipping fee. The tipping fee is based on the actual tonnage that is deposited in the landfill and the Township is charged for that weight. In order to defray that cost the Township has applied yearly for a Performance Grant from the State. The amount received for the grant is

based on the tonnage of the materials recycled in the Township. The more materials recycled the more the Township receives in grant money. Therefore it "pays" to recycle.

The State is now conditioning the receipt of any grant money on the Township's enforcing its recycling program. In other words the State wants the Township to compel its citizens to recycle. The Township does not feel that we should go through your refuse. Rather we will undertake spot checks throughout the Township on your collection days. If it's determined that a resident is not putting

out a recycling bin over a period of time you will receive a reminder notice that recycling is mandatory and will be asked to inform the Township as to the reason for non compliance. Recycling bins, compost bins, and information on both of these programs are available at the Township Office.

We appreciate the recycling efforts of our residents since the program started. We will try to make this State mandated regulation as painless as possible.

## Update on Sewer Planning.

### Where do we stand on sewer?

**What is happening with the on-lot inspections which the Supervisors stated were going to happen this year?**

These are valid questions and have been repeated to the Township many times over the past months. To have an answer one needs to understand the underlying issues and the many aspects of the on-lot inspection program.

As to the first, last year the Board announced that they are reexamining their plan to sewer the Township. Specifically, the Supervisors said they would do an assessment of the current situation in order to determine if certain areas of the Township could function with on-lot systems and into what areas the public sewers would need to be extended. This would be

done by an on-lot inspection program wherein the Township would hire outside firms to conduct inspections of all on-lot systems and to issue reports on each to the Township. The Board of Supervisors would accumulate all of these and map them out on a Township wide basis. At that time, they could evaluate the situation and make a determination of the need for public sewers.

The Township had planned to hire the inspectors in an effort to make the program more affordable. If the individual homeowner were to hire the inspector, the owner would be required to pay 100% of the cost. If the Township hired the inspector, DEP would pay a portion of the cost and the property owner would be responsible for the difference.

When Westtown approached DEP with its inspection plan, DEP notified

the Township that it would not be providing any funds for the program. Feeling that this would result in an unacceptable expense for the residents, the Board of Supervisors has been working for the past few months to get a funding commitment from DEP.

The Township now has DEP's agreement to fund 85% of the inspection cost. All that needs to be done is to make some minor changes in the written plan prepared for DEP. These changes will not alter the program's basic structure.

With this funding commitment, the Township can finalize the paperwork relative to the program. This should be completed in the next couple of months. After that the actual inspections will begin.



## West Chester Area Council of Governments

Westtown Township is a member of the West Chester Area Council of Governments otherwise referred to as a COG or the WCACOG. The WCACOG was formed in 2004 and includes the municipalities of West Chester Borough, West Goshen Township, Thornbury Township, East Goshen Township, East Bradford Township and Westtown Township. These six member municipalities are represented at bi-monthly meetings by elected officials from each municipality.

The mission of the West Chester Area Council of Governments is inter-municipal cooperation with the goal of improving the efficiency of each member municipality through identification and implementation of opportunities for local government cooperation. The WCACOG has established a regional Building Code Appeals Board, 'lobbied' our elected State Representatives and State Agencies like PADOT, and sponsored multi-municipal employee training programs.

The objectives of a council of government like the WCACOG includes improving individual municipal

services through collective efforts and cooperation. To this end we would like to solicit your input for ideas about where we might focus our regional efforts.

## REFUSE & RECYCLING

### RECYCLING AND TRASH INFORMATION

**Computer Recycling** – Staples Office Supply Store is now collection used computers/printers at all their locations. There is a charge of \$10.00 item.

**Holiday Pickup** – The following are the official holidays for A. J. Blosenski: New Years Day, Memorial Day, July 4th, Labor Day, Thanksgiving and Christmas. Trash will not be collected on these days. Your makeup days are: Monday Pickup – trash/recycling is collected the Saturday before the holiday. Thursday pickup your trash/recycling is collected the Saturday after the holiday.

Thank you for your recycling efforts. The Township residential recycling collection for 2007 was 33%. Keep up the good work. If you need a new recycling bin or an extra bin they are available at the Township office. Compost bins also available at the Township office.

<b>How to Prepare Items for Recycling</b>
<b>Glass—Green, Brown &amp; Clear:</b> Bottles or Jars only. Rinse Clean. Remove lids and rings. Labels may be left on. <i>NO plate glass, ceramics, drinking glasses, etc.</i>
<b>Plastic:</b> Must be marked with #1 through #7 inside triangle on bottom. Rinse clean. Remove lids and discard. Labels may be left on. <i>NO unmarked containers or containers marked with other than #1 through #7 inside the triangle on bottom.</i> No antifreeze or motor oil containers.
<b>Aluminum Beverage Cans:</b> Rinse clean. Cans may be flattened. No bottle or jar lids, no pie plates or aluminum foil. <i>No other aluminum items.</i>
<b>Bi-Metal Cans:</b> Rinse clean. Cans may be flattened. Examples include pet food cans, soup cans, vegetable cans. <i>NO cans with plastic parts. NO paint or aerosol cans.</i>
<b>Newspaper, Magazines, Phone Books, Junk Mail, small cardboard boxes (cereal, crackers, etc) &amp; Office Paper:</b> Combine in paper bag or bundle and tie.
<b>Yard Waste (excluding leaves):</b> May be included in regular pickup. Bags of grass not to exceed 50 lbs. Branches acceptable in tied bundles no longer than 3' in length.
<b>Cardboard Boxes:</b> Must be cut in three foot squares, tied and placed next to the recycling bin. This is necessary because of the compacting system of the recycling truck. Unfortunately if the cardboard is not prepared this way it will be taken with the regular trash. Cereal boxes and similar cardboard items may be combined with newspaper.
