Manager’s Report:

In December, 2012, the Board of Supervisors submitted a revised sewer management plan to the Pennsylvania Department of Environmental Protection (DEP). This plan was allowed by a Consent Order with DEP, under which the Township has been operating. The plan submitted did not provide for the extension of any public sewer line. Rather, it put the Township in the role of monitoring all parcels with an on-lot system to ensure that they are being properly maintained. If they are not maintained, then the Township would be required to do so at the owner’s expense.

At this writing, DEP has not notified the Township whether its on-lot management program has been accepted. Until DEP has fully reviewed the plan and given its approval, the Township will not know what form the sewer program will take.

All we can say is – stay tuned. We will notify residents as soon as we receive further information.



2013 Budget Update

By now you have received your Township Real Estate Tax Bill for 2013. For those of you who did not read about it in the local newspaper, meeting minutes, or hear via the grapevine, the Board of Supervisors adopted the 2013 budget, which included a tax increase from 2.5 mills to 3.5 mills on the assessed value of your property. No municipal official wants to raise taxes. This decision was not taken lightly given our difficult economic times. The Board has committed to prepare Westtown to meet the challenges facing our community. This tax increase was deemed necessary to narrow the shortfall between Westtown's future capital needs and identified funding.

The objective of the financial plan is to avoid the "Pay-As-You-Go-Budget" mentality and incorporate "Pay-As-You-Go-Financing", whereby reserves are accumulated for special projects and unplanned expenses. Adequate "Pay-As-You-Go-Financing" combined with increased revenues will ensure Westtown's long-term financial stability.

What does this mean to you, the homeowner? If your taxes are escrowed by a mortgage company, this may result in an escrow shortage for 2013. The assessed value of your property (not the market value) can be found on your tax bill. A mill is worth 1/1000 of a dollar or .001. This assessed value is used to calculate Township, County, and School Taxes.

A sample tax distribution for a Westtown homeowner with an assessed home value of \$200,000 is charted below

Westtown's tax increase is expected to generate approximately \$730,000 in new revenue, which will serve multiple initiatives. These include funding for ongoing infrastructure repairs, street reconstruction, technology improvements such as web site design/maintenance, public works vehicle replacement program and "state of good repair" projects, all of which have been neglected in recent years. New unfunded federal and state mandates are also squeezing an already lean budget and contributing to the shortfall. Additionally, we need to focus on encouraging patterns of growth that will enhance, as well as protect, Westtown's future. To this end, an analysis of the Zoning Ordinances (last full revision in 1991) and an update of the current Comprehensive Plan (last revision 2001) will be placed on the list of initiatives. Obviously, choices regarding the level of funding for each must be weighed and prioritized in a fiscally responsible manner to meet Westtown's target goals. Your elected Board of Supervisors remains committed to the implementation of this multi-year capital program which is updated annually as part of the budget process.

On February 20, 2013 Lt. James DiCave appeared before the West Chester Borough Council to be recognized for his actions on May 6, 2012 during a police emergency in West Chester Borough. Lt. DiCave, a Hostage Negotiator with the West Chester Regional Emergency Response Team, responded to the Justice Center Parking Garage where a male individual was threatening to jump from the top level of the garage. Lt. DiCave recognized the individual from prior police contacts and immediately took the position of lead negotiator. Lt. DiCave was able to talk the individual off the ledge after hours of negotiations.



State Of The Court - *District Court 15-2-03 Westtown, West Goshen & Thornbury Townships*

Dear Friends, Neighbours and Fellow Citizens:

I would like to take this opportunity to extend a warm personal greeting to you. It is difficult for me to believe that I have served as your Magisterial District Judge for the past 5 years. 2013 is an election year and the primary is May 21st. Like last election I will be cross filing on both the Republican and Democratic ballots. I look forward to seeing many of you at the polls.

My first term has gone quickly and it has humbly left me with many life lessons and experiences. I want you to know that I am personally thankful for your continued faith and trust in me. I am committed to continuing to strengthen our community in the coming year. It is the sworn obligation of a Judge to ensure that every case tried in his or her Court is adjudicated expeditiously, courteously, and according to law, with the fullest protection for the rights of all who are involved. I follow this belief daily.

This is my annual "State of the Court" address to the citizens of Westtown Township. 2012 was a busy year for our court. I am proud to report that the state of Magisterial District Court 15-2-03 remains solid, sound and stable and will remain intact with the statewide redistricting.

Pennsylvania's Magisterial District Courts are Courts with limited jurisdiction. More than 90% of all litigation in Pennsylvania occurs in the courtrooms of Magisterial District Judges. Chester County currently has 19 Magisterial District Courts. All summary misdemeanor and felony criminal cases originate at the Magisterial District Court level. Magisterial District Courts are also the venue for lawsuits in civil cases for matters up to \$12,000.00 as well as the filing and disposition of minor criminal cases (summary cases) such as traffic violations, disorderly conduct, public drunkenness, truancy, game law violations, and parking tickets.

As a Magisterial District Judge I conduct preliminary hearings for all serious criminal offenders to determine which cases should be held for trial at the Court of Common Pleas (the trial court). I also set and accept bail and arraign defendants after arrest. This could happen day or night. I issue search warrants based upon testimony from our local police force, state police and the state's Attorney General's office.

Public trust and confidence begins with a fair and impartial judiciary. Every day I and the other District Judges work to pro-

vide resolution of disputes, to protect constitutional rights, and to uphold the rule of law. District Court 15-2-03 is one of the busiest district courts in the county. Our caseload for the year 2012 was 6,070 cases filed. The cases filed in 2012 broke down as follows: 391 criminal cases, 389 civil cases, 4,122 traffic cases, 218 Landlord Tenant cases, and 949 summary cases. For the year 2012 the gross amount of revenue District Court 15-2-03 took in was \$829,674.74. Of that Westtown Township received \$46,775.77.

District Court 15-2-03 is located at the Government Services Center (GSC) 601 Westtown Road, Suite 110 West Chester, PA 19380. Our telephone number is 610-436-5757, our fax number is 610-431-5755 and the Court website is www.chesco.org/judgekraut. The Court's hours are Monday thru Friday 8:30 AM until 4:30 PM. The court's jurisdiction includes Westtown Township, West Goshen Township and Thornbury Township Chester County.

My door is always open. If you have any suggestions on making the court run more efficiently or how our court can better serve the public please let me know. Keep in mind that I cannot and will not discuss a case that I am to hear. The court staff nor I can give legal advice to the public, so please do not get angry at the staff when they tell you they cannot answer your questions. They are under strict orders not to give legal advice. The public and I are very fortunate to have the staff that is employed at our court. They are a dedicated, hard working and conscientiousness group of people. Without them the court would not run as effectively and efficiently as it does.

As always I am available to speak to civic groups, scouts, and schools. Tours of the Court are available for schools and scouts.

In closing as I start each day I try to remember the following "the most extraordinary aspect of the judiciary in a free society is that even while exercising the authority entrusted to them, judges remain the servants, not the masters, of those on whom they sit in judgment."



Oakbourne Park & Mansion



You may know Oakbourne Park as the wooded area off S. Concord Rd where the ball fields and tennis courts reside. You may know Oakbourne Mansion as the old house with the castle-like water tower that sits at the top of the hill. But did you know that both of these places started out as the private home of Mr. and Mrs. John Hulme in the late 1800's? In 1882 James C. Smith of Philadelphia purchased the Hulme's home and 123 acres of land. The Smiths enlarged and refurbished the granite mansion and established a 27-acre park including a small body of water named Oakbourne Lake.

Mr. Smith died in 1893 and his wife three years later. According to her will the property was left to the Philadelphia Protestant Episcopal City Mission with the stipulation that it was to be used as a retreat for sick and convalescent young woman and thus, The James C. Smith Memorial Home was established in 1896.

The home operated for more than 70 years and it has been reported that 15,600 women were guests while the home was opened. Unfortunately, the expense of operating the home became too great, and it was forced to close in 1971.

Westtown Township acquired this gem and its surrounding acres during the 1970's and transformed it into today's Oakbourne Park

Today, Westtown Township and its Parks and Recreation Commission invite you to come and enjoy Oakbourne Park and Mansion! Whether you are new to the township or a lifelong resident, Oakbourne has something to offer everyone.

Boasting 93 acres of wooded land in the heart of Westtown Township, Oakbourne Park offers beautiful trails to hike, walk or run no matter the season. Pets welcome! Oakbourne Pond, nestled in the center of the park grounds, is a great place to while away a sunny afternoon fishing. Or, bring the kids to romp on the playground equipment or use the upper athletic field near the Water Tower for a pickup game of soccer, football, kickball or Frisbee. The Pavilion, equipped with charcoal grill and water source, is available for family and friends who want to party, picnic or play!

The Mansion, which is being refreshed and renewed, is available for touring during Open Houses from 1-3 p.m. on

Sunday, May 19th and Sunday, June 30th. Come see the beauty of its Victorian architecture and carved wood décor. Join the Parks and Recreation Commission for any of the fun events planned throughout the year at Oakbourn Park and Mansion, or plan your own event. 



The Friends of Oakbourne Tree Planting Program

Over the past several years, the Friends of Oakbourne have planted many trees in Westtown Township's Oakbourne Park as part of their efforts to replace dead or dying specimen trees in the park arboretum and to introduce new trees in other areas of the park. As part of the tree planting program, provisions have been made to allow donations from individuals for dedicated or memorial trees to be planted in specific areas of the park and arboretum.



The accompanying map of the arboretum area of the park shows the location of the Friends of Oakbourne's planted trees, both dedicated and non-dedicated. The individuals to whom the dedicated trees commemorate, the date the dedicated tree was planted and the variety of tree are displayed in the accompanying Dedicated Tree table. To find the location of the tree for a particular person, look at the arboretum map and find the red asterisk with the appropriate map number from the table. How to Prepare Items for Recycling

Glass—Green, Brown & Clear:

Bottles or Jars only.

Rinse Clean. Remove lids and rings.

Labels may be left on.

NO plate glass, ceramics, drinking glasses, etc.



Plastic:

Must be marked with #1 through #7 inside triangle on bottom. Rinse clean. Remove lids and discard. Labels may be left on. NO unmarked containers or containers marked with other than #1 through #7 inside the triangle on bottom. No antifreeze or motor oil containers.

Aluminum Beverage Cans:

Rinse clean. Cans may be flattened. No bottle or jar lids, no pie plates or aluminum foil. No other aluminum items.

Bi-Metal Cans:

Rinse clean. Cans may be flattened. Examples include pet food cans, soup cans, vegetable cans. NO cans with plastic parts. NO paint or aerosol cans.

Paper:

Newspaper, Magazines, Phone Books, Junk Mail, small cardboard boxes (cereal, crackers, etc) & Office Paper: Must be in a paper bag or bundled and tied. DO NOT COMINGLE LOOSELY with other recyclables, or your recycling will not be collected.

Yard Waste/Leaves:

Cannot be placed in the regular trash & only collected on scheduled days. Must be in paper bags or in a container that can be dumped. Branches must be three feet in length and tied. Yard Waste collection dates are posted on the Township website www.westtownpa.org, in the Township Gazette, and on your utility bills.

Cardboard Boxes:

Must be cut in three foot squares, tied and placed next to the recycling bin. This is necessary because of the compacting system of the recycling truck. Unfortunately if the cardboard is not prepared this way it will be taken with the regular trash. Cereal boxes and similar cardboard items may be combined with newspaper.

2013 Trash & Recycling Information

Holiday Pickup Schedule: Trash will not be collected on New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving, and Christmas. For Monday pickups, trash and recycling will be collected the Saturday before the holiday; Thursday pickups will be collected the Saturday after the holiday.

Household Hazardous and Electronic Waste

Collection: As of January 24, 2013, Pennsylvania law prohibits the disposal of electronic waste in the regular trash. Visit www.chestercountyswa.org for other e-waste collection events scheduled throughout the county.

Large Item Collection:

Bulk items will be picked up on the last collection date of the month. You are allowed to put out three large items, such as appliances without Freon and furniture. Construction debris (shingles, drywall, lumber, etc.) will not be collected. If you are not sure about the disposal of a bulk item please contact the Township.

Freecycle:

Do you have an item that you no longer need? Consider joining the Freecycle movement. The mission of Freecycle is to keep usable items out of our landfills by offering them to people in your community via an online forum. For more information, visit:


